Not only that, Dilan's way of speaking has also been followed by teenagers today, there is one teenager on the Tiktok application who is currently viral Named Alif, he has followers of up to 1.8M on Tiktok, because with his speaking style like Dilan and wearing Dilan's characteristic jacket, he also became viral.

As Alif went viral on Tiktok with a style like Dilan, Alif also had time to get blasphemy from netizens on Tiktok. But Alif never gives up with the content he makes to entertain his followers, as for one of Alif's content that is currently crowded is when he makes reply content to his followers who ask about the hairstyle he wears. In the video, Alif says, "What model are you asking for hair? let me tell you, my model's hair is a cepmek model, yes Her name, just say bang shave cepmek huh" with the tone that Alif issued had made netizens very crowded on Tiktok. With the words "kamu nanya" and with the accent that Alif uses, many netizens imitate it. Even in their lives, every time someone asks them, they will answer "kamu nanya" with an accent like Alif. Actually, not only Alif imitates Dilan's way of speaking but there are several teenagers who imitate also on various social media applications. The impact of the 1990 Dilan film certainly has a positive and negative impact on teenagers who watch it. In the film, there are many positive impacts that can be taken, for example, such as the figure of Dilan who is kind and loves his family, and also the figure of Milea who is smart, diligent, kind, and obedient with her parents. And there are many more positive impacts that can be taken from the film. But it's not just the positive impact that exists in the film, There are also negative impacts, for example, such as teenagers who want to be like Dilan by following his clothing style, speaking style, and even his attitude. Making them not be themselves but rather become others.

B. The Impact of Online Media

Social media is a virtual communication tool that is currently something that cannot be separated from humans. Teenagers, one of the most social media users who upload their activities and content into social media. In social media a lot of creativity is made by teenagers to get followers and likes and so that they are known to many people. According to a report by Tribun News (22/02/18), the West Kalimantan Provincial Child Protection and Empowerment Office found 23 cases of violence against children. It further quoted Ade A. Yan, head of the Department of Child Protection and Human Trafficking, as saying "These are negative effects of social media use that we can no longer avoid," he said. The next report from People's Mind (28.11.2017) with the title "Social Media-Fueled Student Fights." This news reports on the Indonesian Child Protection Commission's claim that the students' recent struggles are a result of the spread of violent content on social media. "Quantitatively, incidents of physical violence have decreased in Indonesia, but cyber-based incidents have actually increased," said KPAI Chairman Susanto. He stressed that his staff paid special attention to the main issues of violence cases arising from the use of mass media and shared his findings with the then Vice President, Mr. Jusuf Kalla. According to Susanto, the state should handle student disputes and focus on monitoring violent content on social media. "We cannot prevent and avoid this type of technological development. Therefore, protection of children must be guaranteed", he stressed. In addition, Susanto welcomed the government's decision to invite managers of social networks and communication applications such as Facebook and WhatsApp to protect children from negative content. Meanwhile, according to Berita Pikiran Rakyat, KPAI Commissioner for Education Retno Listyarti admitted that many minors use devices and social media in their daily lives. "In practice, this minimum age does not apply. Elementary school children already use Facebook and Twitter because their parents opened their accounts. It's vulnerable," he added. The above two news quotes are just examples. Many parties have been worried about this for a long time. Since the beginning of media studies, scholars have sought to study the impact of violent broadcasts on public behavior.

The positive impact on cultivation theory that researchers can summarize as follows.

1. Adding insight to creativity for teenagers.

2. Get learning to be better than what he sees.
3. Gain new knowledge from what is seen

The negative impact on cultivation theory that researchers can summarize as follows.

Further researchers
