HIMPSI (Indonesian Psychology Association) is the parent organization of Indonesia which operates in the field of psychology. HIMPSI has been established since July 11, 1959, which means that HIMPSI has reached the age of 63 years. HIMPSI was founded because of the response of psychologists working in the government regarding the importance of establishing a professional psychology organization at that time. Initially, HIMPSI was formed with the name ISpsi (Association of Indonesian Psychology Scholars) with the progress of psychology in Indonesia, the name change occurred. The name ISPSI changed to HIMPSI due to changes in the system at professionalism of psychology in Indonesia. This organization is no longer just an association of scholars but has become a forum for gathering psychology professionals at a higher level of education. So this professional organization of psychologists accommodates all psychology professionals , namely bachelors, masters, doctor of psychology and psychologist.

On date 22 October 2000 in Bandung , HIMPSI make code Psychology Ethics in Indonesia, so that psychology in Indonesia can accepted in society. During the founding of this organization, there were many pros and cons of psychology Indonesia. Lots Which has faced psychology in Indonesia One of which is very broad differences in origin in viewing an existing problem, for example regarding differences in theory, methodology, approach and others. Indonesian society has not been able to view psychology in Indonesia from various perspectives as in western countries. but Indonesian society wants something definite science for example like medical science. This made Indonesian society at that time unable to accept and acknowledge psychology in Indonesia.

This organization was established by passing several decisions in Congress. HIMPSI. On congress I HIMPSI produce Articles of Association, code ethics and program Work. On congress II HIMPSI discuss about logo And song. At the III Congress in 1905, the membership and name change of ISPSI to HIMPSI were discussed and determined at the extraordinary congress in April 1998.

Until now, HIMPSI has reached the XIV Congress which resulted in the Psychologist being elected as the General Chairperson of the HIMPSI Central Board who will serve in 2022 to 2026 replacing Prof. Dr. Seger Handoyo, Psychologist.

HIMPSI on year 2023 own 34 region HIMPSI Which spread across 34 provinces throughout Indonesia and 20 Associations/Associations under its coordination. Member HIMPSI moment This amount to more from 18,226 person (October 1, 2022). Until now, HIMPSI has been a member of ARUPS (ASEAN Regional Union Psychological Society), APPA (Asia Pacific Psychology Alliance), IUPsyS (International Union of Psychological Science) and GPA (Global Psychology Alliance).

Objective HIMPSI is: develop professionalism psychologist And scientist psychology in accordance with the required competencies by referring to the Indonesian Code of Ethics of Psychology , developing Psychology as a science and profession that is as broad as possible and beneficial for Indonesian society , implementing Psychology that is in harmony with the reality of the diversity of Indonesian society , protecting members in carrying out professional and scientific activities based on the Indonesian Code of Ethics of Psychology , providing protection to public user psychological services according to the Indonesian Psychology Code of Ethics

HIMPSI vision is to become a nationally recognized professional psychology organization. and also international And play a role increase quality community life. HIMPSI main mission is the development of psychology science and profession in Indonesia. The members HIMPSI consists of member Normal, consists of from Psychologist And Scientist Psychology. Extraordinary Members consist of psychology observers and foreign psychologists. Honorary members consist of individuals who are appointed for their outstanding services to the science and profession of psychology or for their contributions to the advancement of psychology education.

Some of the programs offered by these organizations include professional training and certification, scientific research and publication, collaboration with other institutions at home and abroad, advocacy for professional rights, and service consultation And guidance professional for society. Through these programs, HIMPSI seeks to make a positive contribution to the development of the psychology profession in Indonesia and strengthen the role of psychology in building a prosperous society.
